'Gladstone Centre Plaza Shop Local, Score Big 2026' PROMOTION

TERMS AND CONDITIONS

These terms and conditions are for all entrants who enter the 'Shop Local, Score Big 2026' ("Promotion").

Participation in this Promotion is deemed acceptance of these Terms and Conditions.

The "Promoter" is Fawcner Property Ltd ATF The Trustee for Private Property Trust No.22.

1. Information on '**How to Enter**' forms part of these terms and conditions (Conditions of Entry). Entry into the Shop Local, Score Big Rewards (the "Promotion") is deemed to be an acceptance of the following terms and conditions. Entries must comply with these conditions to be valid.
2. **Who can enter?** Entry is only open to Australian residents. Management, employees, retailers, tenants of participating centres and their immediate families associated with this Promotion are eligible to enter the Customer Competition. Staff and Retailers of Gladstone Centre Plaza are eligible to donate to the Points for a junior sports club but must not present receipts from their own store.
3. This Promotion is restricted to clubs which have registered their participation with the Promoter, as set out in clause 8.
4. **Promotion Period:** The Promotion opens at 9.00am Monday 9 February 2026 and closes at 5.00pm on Tuesday 31 March 2026.
5. **How to enter?**

The Shop Local, Score Big Rewards competition is made up of two parts.

Junior Sports Club Competition: Clubs can nominate themselves or have others nominate them to participate in the program. Up to 5 junior sports clubs will then be selected to participate. Clubs compete for a share of three (3) prizes, 1st \$1,500, 2nd \$1,000, 3rd \$500 in Centre Gift Cards. Shoppers can donate receipts which will be allocated as points during the promotional period to support their local junior sports club by registering as a 'Shop Local, Score Big Rewards Member'.

6. **Customer Competition:** A shopper can support their local junior sports club with their receipt/s donations and be entered into the weekly draw to win the customer competition prize; a \$100 Gladstone Centre Plaza Gift Card. Registration of the 'Shop Local, Score Big Rewards' membership is open from 9.00am Monday 23 February 2026 and closes at 5.00pm on Tuesday 31 March 2026 and can be completed online at <https://woobox.com/qkmbhk>. The closing time for the donations is 5.00pm on Tuesday 31 March 2026.
 - Receipts must be from a participating retailer at Gladstone Centre Plaza.
 - Receipts must be dated within the Promotion Period to be valid.
 - Receipts are invalid if illegible, forged, mutilated, copied or tampered with in any way.
 - Receipts will be validated within 48 hours of submission and added to the tally.
 - The more receipts you submit the better your chances of winning the shopper prize.

- Soliciting for receipts from customers within the centre and surrounding areas is prohibited.
- The Promoter reserves the right to verify the validity of receipts and to disqualify any entrant who tampers with the entry process or who submits a receipt that is not in accordance with the Conditions of Entry.
- Receipts from bill payments such as the payment of credit card bills, ATM or bank transactions, bank fees and charges, service bills (such as gas, electricity, rates and phone bills), cash advances/withdrawals, account charges, government fees and interest charges are not accepted as part of the Promotion.
- Receipts from purchases over \$5,000, transaction receipts, medical service expenses, gift voucher purchases, lottery transactions, business purchases over \$5,000 and lay-by payments are not accepted as part of the Promotion.
- Receipts from tobacco, prescriptions, currency and TAB will not be accepted as part of the Promotion.
- The Promoter reserves the right to make a copy of or mark any receipts used by an entrant to enter this Promotion.
- The winning sports club must provide suitable identification to the Promoters' satisfaction to be entitled to claim the prize.

6. Details of the Registered Club Prize: The top five (5) sports clubs will be judged by the most points allocated during the Promotion Period. There are three (3) prizes to be won in accordance with clause 10.

- Prizes will be awarded to the winning sports club in the form of Gladstone Centre Plaza Gift Cards for the winning prize amount. The winning sports clubs will be contacted by email by Tuesday 7 April 2026.
- The winners will be announced on Friday 10 April 2026 and published to the Gladstone Centre Plaza facebook page by Monday 13 April 2026.
- The final ranking of each sports club will be determined by the sports clubs overall participation in the Promotion (the total number of points allocated). In the event that two or more sports clubs have earned the same amount of total points the prize pool will be added together and divided between those sports clubs.

7. Details of the Individual Customer Competition: Customers are invited to register as a Shop Local, Score Big Rewards ("Shop Local, Score Big Rewards") member during the Promotion Period to participate for their chance to win a \$100 Gladstone Centre Plaza Gift card weekly during the Promotional period.

To register, customers must visit <https://woobox.com/qkmbhk> and register their details online.

- Each time a customer submits receipts, they are automatically entered into the Customer Competition ("Customer Competition") draws.
- Customers will receive one entry per receipt upload from a receipt from any participating retailer during the promotional period.
- Receipts must be dated within the Promotion Period.

- The more receipts a customer uploads the more entries they have into the draw.
- The winners of the Customer Competition prizes will be determined by a random electronic draw. There are five prizes to be won in accordance with clause 10.
- The winners of the Customer Competition must provide suitable identification to the promoters' satisfaction to be entitled to claim the prize.
- The prizes are not redeemable for cash and not transferable and must be taken as offered by the Promoter.
- The winners of the Customer Competition prize will be notified by phone within 48 hours of the draws taking place.
- The Prize must be picked up from Centre Management, during office hours. A Participant claiming to be a Prize Winner will be required to provide proof of identity.
- If despite every reasonable effort, the prize winner cannot be contacted within 2 weeks of the draw taking place, a re-draw will take place.
- Customers who combine receipts with other shoppers will be excluded from the individual customer draw. The customer draw is strictly for individual entries only. Determined at the promoter's discretion.

- 9. - 10. Prizes:** Prizes are not transferable or exchangeable and may not be redeemed for cash and must be taken as offered. Variety of products is based on availability and while stocks last. All prizes are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any prize to the extent permitted by law. The Promoter reserves the right to substitute any prize with a prize of equal or greater value (including where the prize is unavailable for whatever reason), subject to approval of the gaming authorities in each State and Territory where required.
